ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

Pursuant to the provisions of Sections 617.1001, 617.1002 and 617.1006 of the Florida Not For Profit Corporation Act, Jewish Family Services Of Greater Orlando, Inc., a corporation organized and existing under and by virtue of the Florida Not for Profit Corporation Act (the "Corporation"), does hereby certify:

- The name of the Corporation is JEWISH FAMILY SERVICES OF GREATER ORLANDO, INC.
- The original Articles of Incorporation for the Corporation were filed on December 19, 1978 and assigned Charter No. 745303. Said Articles were amended and restated on November 16, 2000 by the filing of Amended and Restated Articles of Incorporation with the Florida Department of State.
- The Articles of Incorporation of the Corporation provide that such Articles may be amended by resolution of the Board of Directors
- The following amendments were by majority vote of the Directors at a meeting held on the 10th day of November 2008. Such vote was sufficient for the approval of such amendments. There are no members entitled to vote on the amendment.
