ARTICLE 1

NAME

The name of the Corporation shall be <u>SUNSET-HILLS</u> <u>ROYAL POINT</u> CONDOMINIUM ASSOCIATION, INC., a Corporation Not For Profit, which is referred to herein as the Association.

ARTICLE II PURPOSE
