

OF

ORDER OF SONS OF ITALY IN AMERICA, INC.,  
JOHN PAUL I LODGE NO. 2427  
St. Petersburg, Florida  
(A Corporation Not for Profit)

We, the undersigned, with other persons being desirous of forming a corporation to further the goals and ideals of the Order of Sons of Italy in America, under the provisions of Chapter 617, of the Florida Statutes, do agree to the following:

ARTICLE I, NAME

The name of this corporation is the Order of Sons of Italy in America, Inc., John Paul I, Lodge No. 2427, St. Petersburg, Florida.

ARTICLE II, PURPOSES

This corporation is organized for the purposes set forth in the Charter of the Order of Sons of Italy in America:

- (a) to enroll in its membership all persons of Italian birth or descent and all others as prescribed in Article I of the General Laws;
- (b) to promote national education and secure adequate laws for the benefit of its members by active participation in the political, social and civic life of our communities;
- (c) to encourage the dissemination of Italian culture in the United States and uphold the prestige of the people of Italian heritage in America;
- (d) to initiate and organize movements for patriotic and humanitarian purposes, thereby establishing a motto of "Liberty, Equality and Fraternity."

This corporation shall have the power to exercise any and all corporate powers set forth in Fla. Stat. 617.021 (1974).

ARTICLE III, QUALIFICATIONS OF MEMBERS

The membership of this corporation shall be constituted of all persons hereinafter named as subscribers and such other persons as, from time to time, may become members in the manner provided in the by-laws, provided, however, that no person shall be admitted to membership in this corporation who is not an adult person possessing the following qualifications:

1. The prospective member must be an American citizen at least 18 years of age at the time of admittance.

2. The prospective member must be of Italian origin or be married to a person of Italian origin.

3. The prospective member must be of good moral character.

All persons accepted for membership in this corporation shall be required to pay membership dues, from time to time, at such time and in such amount as provided in the by-laws.

ARTICLE IV, TERM OF EXISTENCE

This corporation is to exist perpetually.

Section 1. The officers of the corporation shall be a Venerable, Assistant Venerable, Orator and Recording Secretary and other such officers as the Charter and by-laws may from time to time provide for. The affairs of the corporation shall be managed by the Venerable, Assistant Venerable, Orator and Recording Secretary. The corporation may, in addition to the Venerable, Assistant Venerable, Orator and Recording Secretary, have such other officers and trustees as may be provided in the by-laws. Each officer shall be a member of the corporation.

Section 2. The officers shall be elected at the annual meeting of the membership or as provided in the by-laws.

Section 4. The members of the Board of Directors shall be elected and hold office in accordance with the by-laws. The number of members of the Board of Directors shall be as set forth in the by-laws, however, it shall never be less than three.

ARTICLE VIII, BY-LAWS

Section 1. The Board of Directors of this corporation may provide such by-laws for the conduct of its business and the carrying out of its purposes as a majority of the Board of Directors may from time to time deem necessary.

Section 2. Upon proper notice, the by-laws may be amended, latered, or rescinded by a majority vote of those members of the Board of Directors present at any special meeting called for that purpose.

ARTICLE IX, AMENDMENTS

These Articles of Incorporation may be amended at a special meeting of the membership, called for that purpose, by a two-thirds majority vote of those present, with due notice given to the general membership at least fifteen days prior to such special meeting. Amendments to these Articles of Incorporation may be proposed by any member at a meeting of the Board of Directors. The Board of Directors shall, prior to the adjournment of the meeting at which an amendment to these Articles of Incorporation is proposed, vote upon the question of whether a special meeting of the membership shall be called for the purpose of amending these Articles of Incorporation. No special meeting of the membership shall be called for the purpose of amending these Articles of Incorporation unless approved by a two-thirds majority vote of the Board of Directors present at the meeting during which an amendment is proposed.


