ADOPTED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF CARIBBEAN BEACH CLUB ASSOCIATION, INC.

ARTICLES OF INCORPORATION:

1. Adopted amendment to Article VI, Section 1., Articles of Incorporation, to read as follows:

ARTICLE VI.

Section 1. The affairs of the Corporation shall be managed and governed by a Board of Directors composed of not less than three (3) nor more than the number specified in the By-Laws. The Directors, subsequent to the first Board of Directors, shall be elected at the annual meeting of the membership, for a term of one (1) year, or until their successors shall be elected and shall qualify as set forth in the By-Laws. Provisions for such election, and provisions respecting the removal, disqualification and resignation of Directors and for filling vacancies on the directorate, shall be established by the By-Laws.

2. Adopted amendment to Article IX, Articles of Incorporation, to read as follows:

ARTICLE IX.

- . . . the By-Laws may be amended, altered, supplemented or modified by the membership at the annual meeting, or at a duly convened special meeting of the membership, by vote, as follows: set forth in the By-Laws.
 - A. If the proposed change has been approved by the unanimous approval of the Board of Directors, then it shall require only a majority vote of the total membership to be adopted.
 - B. If the proposed change has not been approved by the unanimous vote of the Board of Directors, then the proposed change must be approved by three-fourths (3/4ths) of the total vote of the membership.
