



ARTICLE OF AMENDMENT TO THE RESTATED ARTICLES OF INCORPORATION OF RAINBOW SPRINGS PROPERTY OWNERS ASSOCIATION, INC.

Adopted amendment to ARTICLE VII, Section 4 of the Restated Articles of Incorporation of Rainbow Springs Property Owners Association, Inc., to read as follows:

ARTICLE VII DIRECTORS

, . .

Section 4. Duration of Office. Members elected to the Board of Directors shall hold office <u>as provided in the By-Laws</u>. until they resign or until the next succeeding annual meeting of members, and thereafter until qualified successors are duly elected and have taken office. Directors shall serve no more than four consecutive years.
