The undersigned submits these Articles of Amendment pursuant to Section 617.1006 of the Florida Statutes:

1. The name of the corporation is Florida Gulf Coast Art Center, Inc.;
2. The text of the only amendment adopted is as follows:

Article I of the Articles of Incorporation of the corporation shall be amended to change the name of the corporation to Gulf Coast Art Museum, Inc., as follows:

Article I. The name of the corporation shall be Gulf Coast Museum of Art, Inc., whose mailing address is 222 Ponce de Leon Boulevard, Belleair, Florida 34616.
