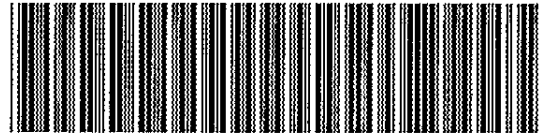

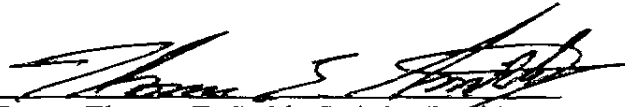
RE: Name Change

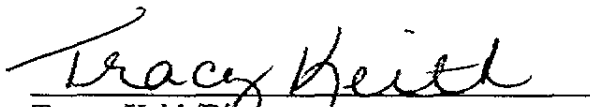
