AMENDMENTS TO THE ARTICLES OF INCORPORATION OF GREENS CAY HOMEOWNERS ASSOCIATION, INC.

The original Declaration of Covenants and Restrictions is recorded in Official Records Book 3207, Page 1758 of the Public Records of Palm Beach County, Florida.

As used herein, words <u>underlined</u> are added and words stricken through are deleted.
