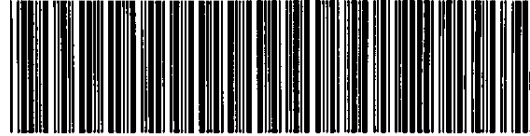



FIRST: The current name of the corporation is SPANISH WELLS HOMEOWNERS ASSOCIATION, INC., filed under Document No. 746321.



THIRD: The amendment to the Articles of Incorporation was adopted by the membership on the 13th day of April, 2016.


FOURTH: The number of votes cast were sufficient for approval.


