EXHIBIT "1"

AMENDMENT TO THE ARTICLES OF INCORPORATION OF CORNICHE CONDOMINIUM APARTMENT ASSOCIATION OF THE PALM BEACHES, INC.

The original Declaration of Condominium of Corniche, a Condominium, is recorded in Official Records Book 3643, Page 1045, et seq., Public Records of Palm Beach County, Florida. The Articles are an Exhibit to the Declaration.

(Words <u>underlined</u> are added and words lined through are deleted)

Article XI, Section 1 of the Articles of Incorporation is amended as follows:

Section 1. The Articles of Incorporation may be amended by the members at a duly constituted meeting for such purpose, provided, however, that no amendment shall take effect unless approved by a majority of the members of the Board of Directors and by members representing at least seventy-five (75%) percent two-thirds (2/3rds) of the votes in the condominium, as set forth in the Declaration of Condominium. Any amendment to the Articles of Incorporation may also be approved by any member of the Board of Directors or by any member by an instrument in writing executed before, during or after said duly constituted meeting. Notice of the subject matter of any proposed amendment shall be included in the notice of any meeting at which a proposed amendment is considered.
