Pursuant to the provision of Chapter 617, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

**FIRST:** The name of the corporation is:

EVANGEL TEMPLE MISSIONARY CHURCH, INC.

**SECOND:** The following amendment(s) to the articles of incorporation was (were) adopted by the corporation:

AMENDMENT 1. That the name of the Corporation be changed to: EVANGEL MINISTERS FELLOWSHIP, INC.

AMENDMENT 2. That ARTICLE VI The last paragraph reading: "The Board of Directors shall be elected yearly by the members of the Church, on the first Sunday in May or as soon as practical, upon due notice to the membership," be changed to read: The term of the Board of Directors shall be indefinite.

AMENDMENT 3. That ARTICLE XI, The last statement reading as follows: "The powers of the members shall be to nominate and vote for each member of the Board of Directors", Is to be eliminated.
