



The Articles of Incorporation of Court Yards Condominium Association, Inc. were filed with the Florida Secretary of State on April 5, 1979. The same Articles of Incorporation were recorded in Official Records of Martin County, Florida at Official Records Book 481, Page 647 (as part of the Declaration recorded at Official Records Book 481, Page 617). Court Yards Condominium Association, Inc., by its duly authorized officers, hereby certifies that the amendments to these Articles were approved by the Board of Directors by Unanimous Written Consent and by the Membership by vote sufficient for approval at the Members' Meeting held on April 14, 2018.

1. Article 5 is amended to read as follows:

5.1 Number and Qualification. The affairs of the Association shall be managed by a board consisting of the number of directors determined by the By-Laws. Directors must be members of the Association.

(The balance of Article 5 remains unchanged)

2. The foregoing amendment to the Articles of Incorporation of Court Yards Condominium Association, Inc. were adopted by the Board of Directors by Unanimous Written Consent and by the Membership by vote sufficient for approval at the Members' Meeting held on April 14, 2018.

3. All provisions of the Articles of Incorporation of Court Yards Condominium Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.






