**ARTICLES OF DISSOLUTION  
OF  
CHURCH OF CHRIST AT CARROLLWOOD, INC.**

Pursuant to Section 617.1403 of the Florida Not for Profit Corporation Act, the Church of Christ at Carrollwood, Inc., a Florida not for profit corporation (the "Corporation"), submits the following Articles of Dissolution:

- FIRST:** The name of the Corporation as currently filed with the Florida Department of State is Church of Christ at Carrollwood, Inc.
- SECOND:** The document number of the Corporation is 746982.
- THIRD:** The resolution to dissolve the Corporation was adopted at a special meeting of the Members on March 26, 2006. The number of votes cast for dissolution was sufficient for approval.
- FOURTH:** The effective date of dissolution shall be upon the filing of these Articles of Dissolution with the Florida Secretary of State.

**CHURCH OF CHRIST AT CARROLLWOOD, INC.****PLAN OF DISTRIBUTION OF ASSETS**

Pursuant to Section 617.1406, Florida Statutes, the undersigned Trustee of the Church of Christ at Carrollwood, Inc., a Florida not for profit corporation (the "Corporation") certifies as follows:

1. On March 26, 2006, following the recommendation of the Trustees of the Corporation, the Members approved the dissolution of the Corporation and, in compliance with the provisions of Section 617.1406(1), adopted the following Plan of Distribution of Assets:

**PLAN OF DISTRIBUTION OF ASSETS OF  
THE CHURCH OF CHRIST AT CARROLLWOOD, INC.**

Following the dissolution of the Church of Christ at Carrollwood, Inc. (the "Corporation"), its assets shall be distributed in the following manner:

- (a) All liabilities and obligations of the Corporation shall be paid and discharged in accordance with the provisions of Section 617.1406(3)(a) using the money obtained through the sale of the real property owned by the Corporation, located at 13345 Casey Road, Tampa, Florida 33618, to Hillsborough County pursuant to a Contract for Sale and Purchase of Real Property dated January 11, 2006.
- (b) Assets held by the Corporation upon condition requiring return, transfer, or conveyance, which condition occurs by reason of the dissolution, shall be returned, transferred, or conveyed in accordance with such requirements and provisions of Section 617.1406(3)(b);
- (c) Assets received and held by the Corporation subject to limitations permitting their use only for charitable, religious, eleemosynary, benevolent, educational, or similar purposes, but not held upon a condition requiring return, transfer, or conveyance by reason of the dissolution, shall be transferred or conveyed to one or more domestic or foreign corporations, trusts, societies, or organizations engaged in activities substantially similar to those of the dissolving Corporation, as provided in this plan of distribution of assets and in accordance with the provisions of Section 617.1406(3)(c);
- (d) Pursuant to the provisions of Article II, Section 8 of the Corporation's Articles of Incorporation, as amended, all of the remaining assets of the Corporation shall be used to further the

exempt purposes of the Corporation and shall be distributed in accordance with Scripture, applicable law (including Section 501(c)(3) of the Internal Revenue Code of 1986), and this plan of distribution of assets as follows:

- (i) The proceeds of the sale of the real property located at 13345 Casey Road, Tampa, Florida 33618 to Hillsborough County after all liabilities and obligations of the Corporation have been paid and discharged will be distributed to the Church of Christ of Citrus Park, Inc.
- (ii) The pews, communion table and podium in the building located at 13345 Casey Road, Tampa, Florida 33618 will be distributed to the Church of Christ of Dade City for their use and to further the exempt purposes of the Corporation.
- (iii) All other property belonging to the Corporation will be transferred to the Church of Christ of Citrus Park, Inc.

2. The undersigned, one of the Trustees of the Corporation, hereby certifies in accordance with the provisions of Section 617.1406(4) that the Corporation has complied with the provisions of Section 617.1406(1).
