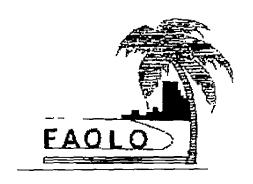

AMENDMENT TO THE ARTICLES OF INCORPORATION

OF

THE FLORIDA ASSOCIATION OF OCCUPATIONAL LICENSING OFFICIALS, INC. (FAOLO)

THIS AMENDMENT, DATED THIS 15TH DAY OF January, 2004 IS AN AMENDMENT TO THE ARTICLES OF INCORPORATION DATED January 18, 1995.

WHEREAS pursuant to the provisions of Florida Statute 617, the aforesaid Articles of Incorporation are amended in their entirety and the following amended Articles are substituted in place therefore:

ARTICLE I - NAME

The name of the corporation shall be THE FLORIDA ASSOCIATION OF OCCUPATIONAL LICENSING OFFICIALS, INC., (FAOLO).

ARTICLE II - PURPOSES

The specific and primary purposes for which FAOLO is formed are to establish a professional association of municipal and county licensing officials who are responsible for the collection directly or indirectly of the occupational license taxes as provided for by the Florida Statutes, and, the members of FAOLO shall work for the betterment of the municipal and county governments they represent.

The general purposes of FAOLO are to encourage close cooperation and a sharing of information between the municipalities and counties represented on all matters relating directly or indirectly with occupational license taxes, work on common problems and each member shall present the solutions to their respective councils or commissions for consideration and implementation, develop needed educational programs that will benefit the members, the community and the municipal and county governments represented.

ARTICLE III - CORPORATE POWERS

FAOLO shall possess all powers granted corporations not for profit under the laws of Florida and shall be subject to all restrictions imposed upon such corporations.

No part of the net earnings of FAOLO shall inure to the benefit of or be distributed to its members, directors, officers, or other private persons except that FAOLO shall be authorized and empowered to pay reasonable compensation for

services rendered and to make expenditures in furtherance of the purposes set forth in Article II hereof.

ARTICLE IV - TERM

FAOLO shall have a perpetual existence.

<u>ARTICLE V - MEMBERSHIP; ADMISSION</u>

REGULAR membership shall be limited to any municipal or county official or other person directly responsible for the collection of municipal or county occupational license taxes in the State of Florida.

ASSOCIATE membership shall be limited to all other municipal or county officials or representatives who are indirectly involved in the occupational licensing process but would derive benefit from such membership.

HONORARY membership shall be limited to retired, regular or associate members, or to those persons who endorse or support FAOLO's purposes in such a way that merits special recognition.

The manner of admission shall consist of completing a membership application, which shall be submitted to the Board of Directors for approval.

The members rights and privileges, their liability for dues and assessments, and the method of collection thereof, and other rules and regulations shall be set forth in the By-Laws.

ARTICLE VII - OFFICERS

The affairs of FAOLO shall be managed by a President, Vice President, Immediate Past President, Treasurer and Secretary who shall perform the usual

functions of said officers together with such additional officers as may be from time to time constituted by the Board of Directors or provided in the By-Laws.

Officers of FAOLO shall be elected by the general membership as provided in the By-Laws. All officers shall continue to serve as provided in the By-Laws. The office held and the name and address of each person serving are as follows:

ARTICLE VIII - BOARD OF DIRECTORS

FAOLO shall be governed by a Board of Directors, each of whom shall be members of FAOLO and shall be elected in the manner provided in the By-Laws.

The Board of Directors may be increased or decreased as provided in the By-Laws. Directors shall hold their office for a period of time as provided in the By-Laws. The names and addresses of the persons who are to serve as directors until their successors are duly elected are as follows:

ARTICLE IX - ADOPTION AND AMENDMENT OF BY-LAWS

The By-Laws of FAOLO may be amended in accordance with Article VI and Article IX of the By-Laws.

ARTICLE X - AMENDMENT OF ARTICLES OF INCORPORATION

Amendments of the Articles of Incorporation shall be proposed by majority vote of the Board of Directors and shall be ratified and approved by a majority of a quorum of the general membership at any regular or special meeting thereof in accordance with Article IX of the By-Laws. Provided that written notice of such meeting containing the text of the proposed amendment be furnished each voting member not less than forty five (45) days prior to such meeting.

It shall be understood by all members of FAOLO that these Articles of Incorporation, as amended, constitute the entire Articles of Incorporation. It supersedes any and all prior understandings and amendments upon any and all subjects covered in this document. Further, that there are no representations or undertakings other than those expressly set forth herein in these Articles of Incorporation of FAOLO.

<u>ARTICLE XI – CHAPTERS</u>

THE board of Directors may organize Chapter Units of FAOLO and such Chapter Units shall be ratified and approved by a majority vote of the Board of Directors.

Each Chapter shall adhere to and be governed by the Articles of Incorporation and the By-Laws.

ARTICLE XII - VOTING RIGHTS

The members voting rights and any limitations to these rights shall be governed by the By-Laws.

ARTICLE XIII - DISTRIBUTION OF ASSETS

Upon FAOLO's dissolution or winding up, its assets remaining after payment, or provision for payment, of all debts and liabilities, shall be distributed

to the governing body of one or more municipal or county governments, to be used for public purpose, and none of the assets will be distributed to any member, officer or director of FAOLO.

The principal office for the transaction of business shall be located in St. Lucie County, Florida.
