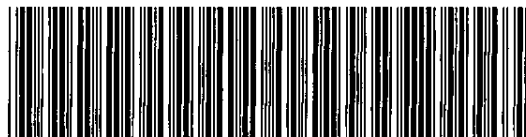

## ARTICLE I - NAME

The name of the corporation shall be THE FLORIDA ASSOCIATION OF BUSINESS TAX OFFICIALS, INC. (FABTO).

## ARTICLE II— PURPOSES

This organization is organized exclusively for charitable, and educational purposes under section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

The specific and primary purposes for which FABTO is formed are to establish a professional association of municipal and county business tax officials who are responsible for the collection directly or indirectly of business taxes as provided for by the Florida Statutes, and, the members of FABTO shall work for the betterment of the municipal and county governments they represent.

The general purposes of FABTO are to encourage close cooperation and sharing of information between the member municipalities and counties on all matters relating directly or indirectly to business taxes;

To consider common problems for members to present solutions to their respective councils or commissions for consideration and implementation;

To develop educational programs that will benefit the members, the community and their respective municipal and county governments.

The organization has established and funds the charitable Adriana Castellano Scholarship Fund for deserving students studying at a State of Florida college or university. The scholarship program pays for tuition and fees of up to \$1,500.00 for one deserving scholar each year as chosen by the recipient university or college foundation.

## ARTICLE III - CORPORATE POWERS

FABTO shall possess all powers granted corporations not for profit under the laws of Florida and shall be subject to all restrictions imposed upon such corporations.

No part of the net earnings of FABTO shall inure to the benefit of or be distributed to its members, directors, officers, or other private persons except that FABTO shall be authorized and empowered to pay reasonable compensation for services rendered and to make expenditures in furtherance of the purposes set forth in Article II.

## ARTICLE IV - TERM

FABTO shall have a perpetual existence.
