The following Article IX is added to the Articles of Incorporation:

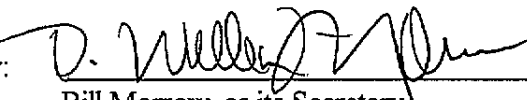

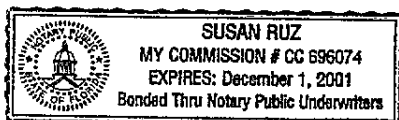
