- FIRST:** The date of filing of the Articles of Incorporation was November 28, 1958, and the date of filing of the Certificate of Reincorporation was June 26, 1979.
- SECOND:** The following amendment to the Articles of Incorporation was adopted by a majority vote of the members entitled to vote, pursuant to Section 617.1002 of the Florida Statutes, at a regular meeting held on January 10, 2001, said majority vote being sufficient for approval:

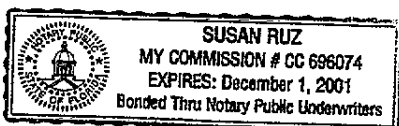
