AMENDMENT TO THE ARTICLES OF INCORPORATION OF AMERICAN ASSOCIATION OF CONDOMINIUMS, INCO.

MARGATE ASSOCIATION OF CONDOMINIUMS, INC., was on girally known as MULTIPLE FAMILY HOMEOWNERS ASSOCIATION, INC., such having been incorporated on June 14, 1979, and recorded on June 27, 1979, under document number 747829. On July 11, 1984, the Articles of Incorporation (hereafter "Articles") were amended to reflect the current name.

MARGATE ASSOCIATION OF CONDOMINIUMS, INC., (hereafter "corporation"), a Florida corporation, having its principal place of business in the City of Margate, Broward County, Florida, hereby certifies to the Florida Department of State, Division of Corporations, as follows:

FIRST: The Articles are hereby amended, pursuant to the provision of the original Articles (Article XII), and §617.1001, §617.1002 and §617.1006, of the Florida Statutes, so as to change the name of the corporation to:

MARGATE ALLIANCE OF CONDOMINIUM AND HOMEOWNERS ASSOCIATIONS, INC.

SECOND: That pursuant to the aforesaid Article XII, notice of the proposed name change was duly given, well prior to the meeting at which the required change was to be considered. The required percentage of members were duly noted and recorded as present at such meeting. The required percentage of votes in favor of the amendment were duly obtained and recorded in the records of the corporation.

THIRD: That the Board of Directors of the corporation unanimously approved the amendment of the corporation's name as set forth herein, and such was recorded in the official records of the meeting held on November 4, 2013.
