

ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SHORE CREST CONDOMINIUM ASSOCIATION, INC.

1. Adopted amendment to ARTICLE II of the Articles of Incorporation of Shore Crest Condominium Association, Inc. (the "Articles"), to read as follows:

ARTICLE II. PURPOSE

The Association is organized as a corporation not for profit under the terms and provisions of Chapter 617, Florida Statutes, and is a condominium association, as referred to and authorized by Section 718.111, Florida Statutes, as the same may be amended or renumbered from time to time. . . .

2. Adopted amendment to ARTICLE III, Section 3 of the Articles, to read as follows:

ARTICLE III. QUALIFICATIONS OF MEMBERS AND MANNER OF ADMISSION

. . .

Section 3. The owner of each condominium unit shall be entitled to at least one (1) vote for each unit owned as a member of the Association. The exact number of votes to be east by owners of a condominium unit and the manner of exercising voting rights shall be determined by the bylaws of the Association.

3. Adopted amendment to ARTICLE VI, Section 5 of the Articles, to read as follows:

ARTICLE VI. BOARD OF DIRECTORS

. . .

Section 5. Directors need not must be members of the Association.
