**ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION  
OF

Pursuant to the provisions of Section 617.1006, Florida Statutes, this Florida Not For Profit Corporation adopts the following amendment to its Articles of Incorporation.

**Corporation Name**

The name of the corporation is THE GREATER TAMPA ASSOCIATION OF REALTORS, INC.

**Text of Amendment**

The amendments adopted by the Corporation (the "**Amendment**") is set out in full as follows:

"ARTICLE VIII- BYLAWS" is hereby deleted in its entirety and replaced with the following:
