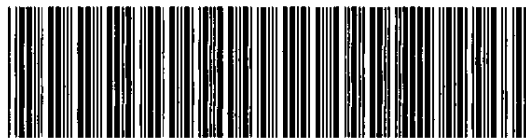

ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
FOR
PALM-AIRE COUNTRY CLUB CONDOMINIUM ASSOCIATION NO. 12, INC.

Pursuant to the provisions of section 617.1006, Florida Statutes, the undersigned corporation adopts the following articles of amendment to its articles of incorporation.

FIRST: Amendment(s) adopted:

Article VI, Section 1, of the Articles of Incorporation is amended to read as follows:

Section 1. The affairs of the Corporation shall be are managed and governed by a Board of Directors as specified in the Bylaws, ~~composed of nine (9) persons, who shall serve staggered terms of three (3) years, with three (3) Directors being elected each year. At the first election subsequent to the effective date of this amendment, the three (3) Directors receiving the highest number of votes shall serve for a term of three (3) years; the three (3) Directors receiving the next highest number of votes shall serve for a term of two (2) years; and the three (3) Directors receiving the next highest number of votes shall serve for a term of one (1) year. Thereafter, all Directors shall serve for a term of three (3) years. The term of each Director's service shall extend until his successor is duly elected and qualified, or until he is removed in the manner provided in Article IV, Section 3 of the By-Laws, or until the Director resigns or is no longer qualified to serve as a Director. All Directors shall be members of the Association. All Officers of a Corporate unit owner shall be deemed to be members of the Association. All Officers of a Corporate unit owner shall be deemed to be members of the Association and so as to qualify as a Director herein.~~
