ARTICLE XII

AMENDMENTS

Amendments to these Articles shall be proposed and adopted in the following manner:

- Notice. Notice of the subject matter of a proposed amendment included 12.1 in the notice of any meeting at which the amendment is to be considered.
- Adoption. A resolution for the adoption of a proposed amendment may be 12.2 proposed either by the Board of Directors or by the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approvals must be either:-

a .-- by not less than 66-2/3% of the votes, of the entire memborship of the Association, and of --- the Directors; or-

b.—by not less than 60 75% of the votes of the entire membership of the □ Association. NHASSE 23
