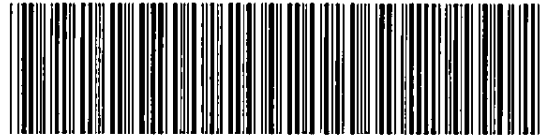

CERTIFICATE OF INCORPORATION
OF
PORTOFINO-ON-THE-INTRACOASTAL
CONDOMINIUM ASSOCIATION, INC.

We, the undersigned, hereby associate ourselves together for the purpose of forming a corporation not for profit under Chapter 617 of the Florida Statutes, and certify as follows:

ARTICLE I.

NAME

The name of this corporation shall be:
PORTOFINO-ON-THE-INTRACOASTAL CONDOMINIUM ASSOCIATION, INC. and shall hereinafter be referred to as the "Condominium Association."

ARTICLE II.

PURPOSE

The purpose for which the Condominium Association is organized is to manage, operate and maintain a Condominium to be known as Portofino-on-the-Intracoastal Condominium. Said Condominium shall be operated on a non-profit basis for the mutual use, benefit, enjoyment and advantage of the individual residents of said Condominium; to make such improvements, additions and alterations to said Condominium as may be necessary or desirable from time to time as authorized by the Declaration of Condominium and the By-Laws of the Condominium Association; to purchase and own personal property; and to conduct and transact all business necessary and proper in the management, operation and maintenance of said Condominium; all as agents of the owners of the Condominium Parcels of the said Condominium.

ARTICLE III.

MEMBERSHIP

All owners of Condominium Parcels in Portofino-on-the-Intracoastal Condominium shall be eligible for membership in the Condominium Association and shall automatically become members upon acquisition of such ownership interest, all as more fully provided in the Declaration of Condominium and the By-Laws of the Condominium Association.

ARTICLE IV.

EXISTENCE AND OFFICE

The Condominium Association shall have perpetual existence. The principal office of the corporation shall be at 77 South Birch Road, Fort Lauderdale, Florida.

ARTICLE V.

ARTICLE VI.

MANAGEMENT

The affairs of the Condominium Association shall be managed by the Board of Directors, which shall elect a President, Vice-President, Secretary and Treasurer and such assistants as may be desirable. Except as provided in Article VIII. herein, Directors of the Condominium Association shall be elected at the annual meeting of the membership, and officers shall be elected at the first meeting of the Board of Directors following the annual meeting of the membership.

OFFICERS

The names of the officers who shall serve until their successors are elected are as follows:

ARTICLE VIII

BOARD OF DIRECTORS

The affairs of the Condominium Association shall be managed by a Board of Directors. The first Board of Directors of the Condominium Association shall consist of three (3) persons, whose names and addresses are as follows:

The first Board of Directors shall serve and shall be administered in accordance with the following guidelines and procedures:

1) So long as Tamco, Inc., a Florida corporation, ("Developer") or its successors or assigns owns title to more than eighty-five percent (85%) of the apartments to be governed by this Condominium Association, it shall have the right to appoint all members of the first Board of Directors.

2) When the Developer shall own title to eighty-five percent (85%) or less of the apartments to be governed by the Condominium Association, Developer shall have the right to appoint two (2) of the three (3) members of the first Board of Directors, and members of the Condominium Association shall be entitled to elect the remaining member at a special members' meeting.

3) Within three (3) years after the Developer has conveyed title to at least fifty percent (50%) of the apartments to be governed by the Condominium Association, or three (3) months after the Developer has conveyed title to ninety percent (90%) of the apartments to be governed by the Condominium Association, or when all of the apartments that will be governed by the Association have been completed, some of them have been conveyed to purchasers, and none of the others are being offered for sale by the Developer in the ordinary course of business, or when some of the apartments have been conveyed to purchasers and none of the others are being constructed or offered for sale by the Developer in the ordinary course of business, whichever occurs first,

the Developer will cause one of its two appointed representatives on the Board of Directors to resign and the members of the Condominium Association shall elect a replacement Director at a special members' meeting.

4) Developer shall retain the right to appoint one member of the Board of Directors so long as it holds for sale in the ordinary course of business at least five percent (5%) of the apartments to be governed by the Condominium Association.

5) At such time as Developer holds less than five percent (5%) of the apartments to be governed by the Association, the Developer will cause its remaining representative on the Board of Directors to resign and the members of the Condominium Association shall elect a replacement Director at a special members' meeting.

6) Replacement Directors shall serve until the first annual meeting of the membership following resignation of the Developer's last appointed Director (said annual meeting herein defined as the "first effective annual meeting").

7) At such first effective annual meeting and at all subsequent annual meetings, the members shall elect from the membership three (3) or more Directors as more fully provided in the By-Laws of the Condominium Association. Notwithstanding any other provision herein to the contrary, the Developer may at any time relinquish its right to appoint Directors and cause its representatives to resign as Directors.

ARTICLE IX.

BY-LAWS

The By-Laws of the Condominium Association shall be adopted by the Board of Directors and may be amended, altered or rescinded by a majority vote of such Board prior to the relinquishment of control of the Board by the Developer. Thereafter, the By-Laws shall be amended, altered or rescinded by a three-fourths vote of the members of the Condominium Association in the manner provided in the By-Laws of the Condominium Association.

ARTICLE X.

AMENDMENT

Prior to the relinquishment of control by the Board of Directors by

the Developer, this Certificate of Incorporation may be amended by a majority vote of the Board of Directors. Thereafter, amendments to the Certificate of Incorporation may be proposed by any member or Director and may be adopted by three-fourths vote of the members of the Condominium Association at the annual meeting of members or at a special meeting of members; provided, however, that in either instance notice of the proposed amendment has been given with notice of the meeting, and provided further that such amendment has first been approved by not less than a majority vote of the Board of Directors of the Condominium Association.

ARTICLE XI.

CORPORATE POWERS

The Condominium Association shall have all of the powers and authority granted to corporations not for profit under Chapter 617 of Florida Statutes, granted to condominium associations under Chapter 718 of Florida Statutes, and in addition thereto and not by way of limitation, the Association shall also have the following authority, to-wit:

a) To exercise complete and exclusive control in the management, operation and maintenance of Portofino-on-the-Intracoastal Condominium for the use and benefit, and as agent, of the individual owners of the Condominium Parcels.

b) To perform all duties and functions as required by this Certificate of Incorporation, the Declarations of Condominium of said Condominium, and the By-Laws of the Condominium Association, and as may be necessary or desirable in carrying out the objectives of the Condominium Association.

ARTICLE XII.

RIGHTS OF MORTGAGEE

If the construction lender, _____, its nominee, designee, or any purchaser acquires title to any portion of Portofino-on-the-Intracoastal Condominium by reason of foreclosure of the construction lender's mortgage thereon (the Mortgage), or conveyance to the construction lender, its nominee, designee, or any other purchaser by deed in lieu of foreclosure of the Mortgage, the construction lender, its nominee, designee, or such other purchaser shall succeed to all of the rights of and

benefits accruing to Developer under this Certificate of Incorporation, and the construction lender, its nominee, designee or such other purchaser shall be entitled to exercise all of the rights of and benefits accruing to the Developer under this Certificate of Incorporation as if the construction lender, its nominee, designee, or such other purchaser was originally named as the Developer in this Certificate of Incorporation.

ARTICLE XIII

INDEMNIFICATION OF OFFICERS AND DIRECTORS

A. The Association hereby indemnifies any director or officer made a party or threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, other than one by or in the right of The Association to procure a judgment in its favor, brought to impose a liability or penalty on such officer or director for an act alleged to have been committed by such officer or director in his capacity of officer or director of The Association. This indemnification shall extend to all judgments, fines, amounts paid in settlement and reasonable expenses, including attorneys' fees, actually and necessarily incurred as a result of such action, suit or proceeding or any appeal therein, if such person acted in good faith and the reasonable belief that such action was in the best interests of The Association, and in criminal actions or proceedings, without reasonable ground for belief that such action was unlawful. Determination of any such action, suit or proceeding in any manner shall not in itself create a presumption that any such director or officer did not act in good faith in the reasonable belief that such action was in the best interests of The Association or that he had reasonable grounds for belief that such action was unlawful.

The officer or director indemnified shall be entitled to indemnification in relation to matters to which such person has been adjudged to have been guilty of negligence or misconduct in the performance of his duty of The Association unless, and only to the extent that, the court, administrative agency, or investigative body before which such action, suit or proceeding is held, shall determine upon application that despite the adjudication of liability but in view of all the circumstances of the case, such person is fairly

and reasonably entitled to indemnification for such expenses which such tribunal shall deem proper.

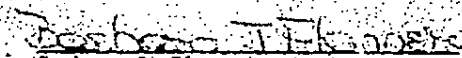
B. The Board of Directors shall determine whether amounts for which a director or officer seeks indemnification were properly incurred and whether such director or officer acted in good faith and in a manner he reasonably believed to be in the best interest of The Association, and whether, with respect to any criminal action or proceeding, he had no reasonable ground for belief that such action was unlawful. Such determination shall be made by the Board of Directors by a majority vote of a quorum consisting of directors who were not parties to such action, suit or proceeding.

C. The foregoing rights of indemnification shall not be deemed to limit in any way the powers of The Association to indemnify under applicable law.
