3. The dissolution of the Corporation was authorized by the Board of Directors and Members by unanimous written consent dated as of November 18, 1999, executed in accordance with Florida Statute, Section 617.0701.
4. The number of Member votes cast for dissolution consisted of 100% of the Members of the Corporation and such vote was sufficient for approval of such dissolution.
5. The Articles of Dissolution shall be effective as of the filing of same with the Florida Department of State.

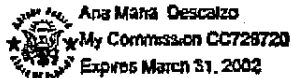
