

EXHIBIT "A"

AMENDMENT TO THE ARTICLES OF INCORPORATION OF PIEDMONT "L" ASSOCIATION, INC.

[Added language is <u>underlined</u>. Deleted language is stricken through.]

Article 12 of the Articles of Incorporation is amended to read as follows:

"ARTICLE 12 AMENDMENTS

Amendments to these Articles shall be proposed and adopted in the following manner:

- 12.1 Notice. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which the proposed amendment is to be considered.
- 12.2 Adoption. These Articles of Incorporation may be amended by written agreement, without a Members meeting, by the Owners of eighteen (18) Units approving the Amendment. Approval by a majority of the Board of Directors is also required for amendment of these Articles of Incorporation.

Amendments to these Articles of Incorporation shall, after adoption, be recorded in the Public Records of Palm Beach County, Florida and filed with the Florida Secretary of State.

A-resolution for the adoption of a proposed amendment may be proposed either by a majority of the Board of Directors or by not less than one third (1/3) of the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing the approval is delivered to the secretary at or prior to the meeting. The approvals must be either

- (a) by not less than 66 2/3% of the votes of the entire membership of the Association and by not less than a majority of the Board of Directors; or
- (b) by not less than 75% of the votes of the entire membership of the Association.
- 12.3 Limitation. Provided, however, that no amendment shall make any changes in the qualifications for membership nor in the voting rights or property rights of members, nor any changes in Sections 1.3, 4.4, and 4.5 of Article 4, entitled "Powers", without approval in writing by all members and the joinder of all record owners of mortgages upon units. No amendment shall be made that is in conflict with the Act or the Declaration, nor shall any amendment make any changes which would in any way affect

any of the rights, privileges, powers or options herein provided in favor of or reserved to the Developer, or an affiliate of the Developer, unless the Developer shall join in the execution of the Amendment.

12.4 Recording. A copy of each amendment shall be filed with the Secretary of State pursuant-to-the provisions of the applicable Florida Statutes, and a copy certified by the Secretary of State shall be recorded in the public records of Palm Beach County, Florida."
