Pursuant to the provisions of Sections ~~607~~ 607.1003 and ~~607~~ 607.1006 of the Florida Statutes, **Fair Haven Baptist Church of Zephyrhills, Inc.**, adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is **Fair Haven Baptist Church of Zephyrhills, Inc.**
2. The original Articles of Incorporation for the corporation were filed on November 2, 1979, and assigned Charter No. 749640, said corporation was administratively dissolved, but has been reinstated on November 2, 2001.
3. By a majority vote on May 8, 2002, by all of the Trustees, officers and members of the corporation respectively, the Trustees, Officers, and Members agreed that the Articles of Incorporation be amended to change the name of the Corporation to **Hidden Creek Community Church Inc.** The amendment was approved by the single class of members and the number of votes cast for approval was sufficient.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

The name of this corporation is
Hidden Creek Community Church Inc.
5. The effective date of these Articles of Amendment is July 15, 2002.
