#### PLAN OF DISTRIBUTION OF ASSETS

This Plan of Distribution of Assets has been adopted unanimously by the Board of Directors of GULF COAST E-I-P CENTER, INC., at a Board Meeting on June 18, 1998. The Plan of Distribution of Assets is as follows:

1. All liabilities and obligations of the corporation are to be paid and discharged by the treasurer of the corporation. A reserve in the amount of \$2,000 shall be maintained for six months during which time any and all final expenses of the corporation shall be paid. Any funds remaining after six months from the filing of the Articles of Dissolution shall be paid as set forth below.

2. The corporation does not hold any assets upon condition requiring return or conveyance upon dissolution.

3. All of the assets held by the corporation are for charitable, religious and educational purposes and upon dissolution of the corporation all of the remaining assets, excluding the reserve set forth above, shall be paid to Manatee Community College, which is an educational organization engaged in activities substantially similar to those of this corporation.

4. The corporation's accountant is directed to prepare the final income tax return and any and all other filings required with respect to the dissolution of the corporation to be filed with the Internal Revenue Service and the Florida Department of Revenue.
