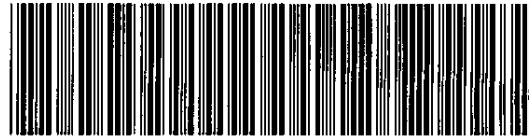



EXHIBIT "A" TO ARTICLES OF AMENDMENT  
TO ARTICLES OF INCORPORATION OF  
BET SEFER ACADEMY, INC.

- A. Article I, titled "Name", is hereby deleted in its entirety and replaced with the following:

The name of the corporation shall be The Academy of Ormond Beach, Inc. For convenience, the corporation shall be referred to in this instrument as "the Academy".

- B. Article II, titled "Purpose", is amended as follows:

1. Section 2.1 is hereby amended to state: "The purpose for which the Academy is organized is to provide a rigorous academic education for children, to prepare children for adulthood, and to be good, responsible citizens. In keeping with the traditions of the founders of the Academy, the Academy shall acknowledge and respect Jewish tradition and culture. However, the Academy shall in all respects be secular in nature and shall welcome students of all faiths and cultures."

- C. Article V, titled "Principal Office and Designation of Registered Agent", is amended as follows:

The principal office of the Academy shall be located at 55 North Washington Street, Ormond Beach, Florida 32174, but the Academy may maintain offices and transact business in such other places within or without the State of Florida as may from time to time be designated by the Board of Directors. The Board of Directors shall also have the right to relocate the principal office. The current registered agent of the Academy is Barbaree Heaster, 1075 Ocean Shore Blvd., #702, Ormond Beach, FL 32176. The Board of Directors may, from time to time, change the registered agent by designation filed in the office of the Secretary of State.
