FIRST ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SHAKERWOOD ASSOCIATION, INC.

FIRST:

The name of the corporation is: SHAKERWOOD ASSOCIATION, INC.

SECOND:

The text of the first amendment to the Articles of Incorporation is to Article VII entitled "Board of Directors", Section A as follows (the language added is <u>underlined</u>; the language deleted is <u>struck out</u>):

ARTICLE VII

Board of Directors

A. The affairs of the Association shall be governed by a Board of Directors consisting of not less than three (3) and not more than nine (9) Directors. The Directors may, but need not, shall be Lot Owners and need not be residents of the State of Florida. No Lot Owner, who is certified by the Treasurer of the Association to be delinquent in the payment of assessments for a continuous period of ninety (90) days immediately preceding any annual or special meeting at which elections of directors are held, shall be eligible to be a Director.

Members are entitled to vote on the proposed Amendment, the date of the adoption of the Amendment by the members being September 30, 1993, and the number of votes cast for the Amendment was sufficient for approval.
