Amendment: Article 10.1, Amended and Restated Articles of Incorporation

10. Amendments. These Articles may be amended in the following manner:

10.1 Proposal of Amendments. An amendment may be proposed by any Director or by any Unit owner a majority of the Directors or by twenty-five percent (25%) of the entire voting interests.
