# Amendment No. 1: Article VII, Amended and Restated Articles of Incorporation

## **ARTICLE VII**

<u>AMENDMENTS</u>: Amendments to these Articles shall be proposed and adopted in the following manner:

(Sections A and B Remains Unchanged)

(C) Vote Required. These Articles of Incorporation may be amended by vote of the members entitled to vote thereon at any annual or special meeting two-thirds (2/3) of the voting interests present, in person or by proxy, and voting at a duly noticed meeting of the Association at which a quorum is obtained, or by approval in writing of a majority of the voting interests without a meeting two-thirds (2/3) of the entire voting interests, provided that notice of any proposed amendment has been given tot he members of the Association, and that the notice contains a fair statement of the proposed amendment.
