The following is an adopted amendment to the Articles of Incorporation of Palma Del Mar Condominium Association No. 4 of St. Petersburg, Inc., recorded in Official Records Book 5132, Pages 270 et seq., within the Public Records of Pinellas County, Florida.

Article IX of the Articles of Incorporation is amended to read as follows:

ARTICLE IX. AMENDMENT TO ARTICLES

The Articles of Incorporation may be amended at any special or regular meeting <u>of the membership</u>, by approval of not less than 75 percent of <u>those members who participate in the voting</u>, in person or by proxy, at a membership meeting, provided that a guorum is obtained, entire membership of the Board of Directors and 75 percent of the members of the Association, or by not less than 80 percent of the votes of the entire membership of the Association. Any amendment to these Articles will be voted upon only after notice of any meeting <u>is provided</u> as required by the Bylaws of the Association.
