Gentlemen:

I represent the Town of Callahan, Florida. Earlier this year the members of your organization separated from the Town of Callahan. There are, at least, two aspects of this separation process which require immediate attention.

First, your continued use of the name "Callahan Volunteer Fire And Rescue Department, Inc." will be misleading to the public. The Town had a volunteer fire department for many years before your non-profit corporation was formed. The Town now maintains a volunteer fire department after the separation of your members from the Town. The Town of Callahan, Florida, is a Florida municipal corporation formed in 1911. Fire protection is an inherent aspect of the health and safety of the residents of the Town. It would be unconscionable for any confusion of names to lead to injury or loss to the Town's residents. Therefore, on behalf of the Town of Callahan, Florida, demand is hereby made that your organization and members immediately cease and desist from any future use of the name Callahan Volunteer Fire And Rescue Department, Inc. Secondly, it appears that your organization is using the Town's Federal employer identification number. Whatever the propriety of past use of the Town's tax number, due to the separation of your organization from the Town any continued use would be clearly improper and illegal. Therefore, on behalf of the Town of Callahan, Florida, demand is hereby made that your organization and members immediately cease and desist from any future use of the Federal employer's identification number assigned to the Town of Callahan, Florida.

Please be advised that it is a violation of law to sign a false document with the intent that it be delivered to the Department of State for filing. Section 617.0129, Florida Statutes (1999). The corporation's name and Federal employer identification number are material to a proper filing with the Department of State, either for the purpose of the annual report or reinstatement. On behalf of the Town of Callahan, Florida, demand is hereby made that corrected information be immediately furnished by your organization to the State of Florida.

Please be governed accordingly.
