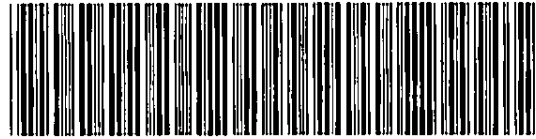



IV.

MEMBERS

The Corporation shall have no members.

VI.

DIRECTORS

A. The affairs, property and business of the Corporation shall be managed and controlled by a Board of Directors consisting of the number of Directors determined by the Bylaws, but not less than three Directors, and in the absence of such determination, the Board shall consist of three Directors.

B. Directors of the Corporation shall at the annual meeting be elected and hold office in the manner determined by the Bylaws of the Corporation. Directors may be removed and vacancies on the Board of Directors shall be filled in the manner provided in the Bylaws.

VII.

OFFICERS

A. The affairs of the Corporation shall be administered by the officers designated in the Bylaws of the Corporation.

B. The officers shall be elected by the Board of Directors at its first annual meeting and shall serve at the pleasure of the Board of Directors.

VIII.

BYLAWS

The Board of Directors of this Corporation shall make, adopt, alter, amend and repeal such Bylaws of the Corporation for the conduct of the business of the Corporation and the carrying out of its purposes as such Directors may deem necessary from time to time. The Bylaws may be altered, amended or repealed in the manner provided in the Bylaws.

IX.

AMENDMENT

The Articles of Incorporation may be amended by a two-thirds vote of the Directors of the Corporation at a regular meeting or at a duly called special meeting of the Directors upon notice given, as provided by the Bylaws, of intention to submit such amendments to the Directors of the Corporation.
