CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF INDIAN RIVER LANDING CONDOMINIUM ASSOCIATION, INC.



A Not For Profit Corporation, Incorporated Florida, 1978

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of Indian River Landing Condominium Association, Inc. were filed with the Florida Secretary of State on December 28, 1979. The same Articles of Incorporation were recorded in Official Records of St. Lucie County, Florida at Official Records Book 360, Page 2903, et. seq. The same Articles of Incorporation are hereby amended as approved by at least seventy-five percent (75%) of the Board of Directors at a Board Meeting held on May 4, 2010 and by at least seventy-five percent (75%) of the Membership, which vote was sufficient for approval, at the Members' Meeting held on June 15, 2010 and reconvened on June 29, 2010.

Article IX is amended to read as follows:

IX AMENDMENTS

Amendments to these Articles of Incorporation shall be proposed and adopted in the following manner:

- 9.1 Notice. Notice of the subject matter of a proposed amendment shall be included in the notice of any meeting at which the proposed amendment is to be considered.
- 9.2 Adoption. A resolution for the adoption of a proposed amendment may be proposed either by the Board of Directors or by twenty-five (25%) of the members of the Association. Directors and members not present in person or by proxy at the meeting considering the amendment may express their approval in writing, providing such approval is delivered to the secretary at or prior to the meeting. Except as elsewhere provided:
- a. Such approvals must be by not less than a majority of the entire membership of the Board of Directors and by not less than a majority of the votes of the entire membership of the Association; or

- b. By not less than 85% of the votes of the entire membership of the Association.
- 9.3 Limitation. Provided, however, that no amendment shall make any changes in the qualifications for membership nor in the voting rights of members, without approval in writing by all members and the joinder of all record owners of mortgages upon the condominium properties. No amendment shall be made that is in conflict with the Condominium Act or the Declaration of Condominium.
- 9.4 Recording. A copy of each amendment shall be accepted and certified by the Secretary of State, and shall be recorded in the public records of St. Lucie County, Florida.

(The balance of Article IX remains unchanged)

- 2. The foregoing amendment to the Articles of Incorporation of Indian River Landing Condominium Association, Inc. was adopted by at least seventy-five percent (75%) of the Board of Directors at a Board Meeting held on May 4, 2010 and by at least seventy-five percent (75%) of the Membership, which vote was sufficient for approval, at the Members' Meeting held on June 15, 2010 and reconvened on June 29, 2010.
- 3. The adoption of this amendment appears upon the minutes of said meetings and is unrevoked.
- 4. All provisions of the Articles of Incorporation of Indian River Landing Condominium Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
