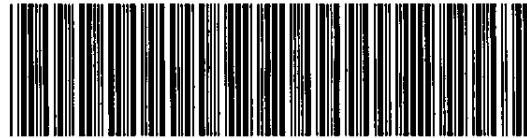




It is with deep regret and sadness that I must resign my position as Secretary of the Williamsburg Homeowner's Association (W.H.O.A.) for personal reasons.
