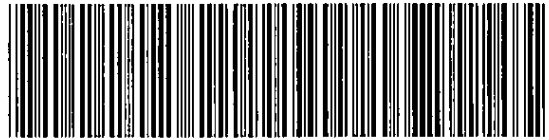

**ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF**  
**ARROWHEAD VILLAGE OF THE TRAILS HOMEOWNER'S ASSOCIATION, INC.**

Pursuant to the provisions of Section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendment to its Articles of Incorporation:


Article III (b)

~~If the record title holder described in paragraph a designates in writing to the secretary of the association, the tenant shall be a member of this association. However, owner's membership privileges during the period of such tenancy shall abate and be exercisable only by the tenant. When the tenancy ceases to exist, the owner of such dwelling unit shall so certify to the secretary of this association and the owner shall be entitled to resumption of all membership privileges unless a new tenant is in possession of the dwelling unit.~~
