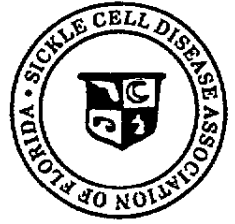

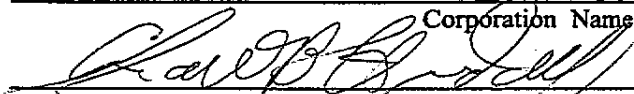

ARTICLES OF AMENDMENT
to
ARTICLES OF INCORPORATION
of
SICKLE CELL DISEASE ASSOCIATION OF AMERICA PALM BEACH COUNTY
CHAPTER, INC.

The undersigned, acting as officers/directors of a Corporation Not For Profit under the Florida Not for Profit Corporation Act, hereby adopts the following Amendments to Articles of Incorporation, to be effective as of May 1, 2000.

I. ARTICLE I NAME is amended to read:

The name of this corporation is: SICKLE CELL FOUNDATION of Palm Beach County, Inc. whose principal office shall be 1600 North Australian Avenue, West Palm Beach, Florida 33407.

II. ARTICLE VI OFFICERS is amended to read:

The business affairs of this corporation shall be managed by the Board of Directors and the officers. The officers shall be elected at the annual meeting held each year in the month of December. The members of the Board of Directors shall be appointed each year at the annual meeting.

The officers of the corporation shall be: President, Vice President, Recording Secretary, Corresponding Secretary, Treasurer and such other officers as may be provided in the By-laws.

The officers shall be elected by the membership present at the Annual Meeting of the corporation to be held in the month of December.

III. ARTICLE XI LOCATION is amended to read:

The location of this corporation shall be at: 1600 North Australian Avenue, West Palm Beach, Florida 33407. However, the corporation may change the location of its principal office from time to time.

IV. These Amendments were adopted by the members on the 19 day of April, 2000.

V. All other Articles of the Articles of Incorporation of SICKLE CELL FOUNDATION OF PALM BEACH COUNTY, INC. shall remain in full force and effect.
