### ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF SCOTTISH TOWERS CONDOMINIUM ASSOCIATION, INC.

#### ADDITIONS INDICATED BY <u>UNDERLINE</u> DELETIONS INDICATED BY <u>STRIKE THROUGH</u> OMISSIONS INDICATED BY ELLIPSIS....

1. Article I, Name, of the Articles of Incorporation, shall be amended to read as follows:

I.

#### Name

The name of the corporation shall be SCOTTISH TOWERS DOLPHIN POINTE OF DUNEDIN CONDOMINIUM ASSOCIATION, INC. For convenience the corporation shall be referred to in this instrument as the Association.

- 2. Article II, Purpose, section 2.1, of the Articles of Incorporation, shall be amended to read as follows:
  - 2.1 The purpose for which the Association is organized is to provide an entity pursuant to the Florida Condominium Act, which is Chapter 718, Florida Statutes, for the operation of SCOTTISH TOWERS DOLPHIN POINTE OF DUNEDIN CONDOMINIUM, according to Declaration of condominium now or hereafter recorded in the Public Records of Pinellas County, Florida, located upon lands in Pinellas County, Florida.
- 3. Article IV, Members, section 4.1, of the Articles of Incorporation, shall be amended to read as follows:
  - 4.1 The members of the Association shall consist of all of the record owners, by deed or otherwise, of condominium apartments in SCOTTISH TOWERS DOLPHIN POINTE OF DUNEDIN CONDOMINIUM, but shall in no event exceed 70 members; and after termination of the condominium shall consist of those who are members ät the time of such termination and their successors and assigns.
