Pursuant to the provisions of Chapter 607 of the Florida Statutes and the Florida Business Corporation Act, the undersigned hereby provides the following amendment to the Articles of Incorporation of JAMI ALL SELAM, INC., a Florida not for profit corporation (the "Corporation").

1. An additional Article shall be added to the Articles of Incorporation of JAMI ALL SELAM, INC. as follows:

"ARTICLE XIII: DISSOLUTION

In the event of dissolution of the Corporation, no member, director or officer shall be entitled to or receive any distribution or division of its remaining property or its proceeds, and the balance of all money and other property received by the Corporation from any source, after the payment of all debts and obligations of the Corporation, shall be used or distributed exclusively for charitable, religious or educational purposes within the intendment of Section 501(c)(3) of the Internal Revenue Code as the same now exists or as its may be amended from time to time."

2. The foregoing amendment was adopted by the Members and Directors of this Corporation on March 27, 1999.
