Amendments to the Constitution and Regulations Of the Homeowner's Association of Lone Pine West

Rewrite Article II Article II

<u>Members</u>: All homeowners of mobile homes having paid their annual membership fees, amount chosen by the Homeowner's Administrative Council and approved by the General Assembly, becomes a member of the Association which is recognized as official representative body in cases such as:

- 1. Negotiations, agreements and legal matters affecting the owner's of mobile homes in the Association.
- 2. Rent disputes, landlord-owners disputes, and those matters affecting the Association in general.
- 3. To sue and be sued as the legal entity representing the Association

Each member in proper standing order with the Association benefits from the right to vote and all other rights and privileges as described by the Constitution. Homeowner's who have not paid their annual fee will be able to assist any Association meeting as spectators only, without the right of speech and without voting rights.
