AMENDMENTS TO THE ARTICLES OF INCORPORATION OF VILLAS OF VILLAGE GREEN PROPERTY OWNERS' ASSOCIATION, INC.

The Articles of Incorporation of Village Green Property Owners' Association Inc. were recorded with the Florida Secretary of State on March 26, 1980 and filed in the public records of St. Lucie County, Florida at Official Records Book 1073, page 794 erised and an Amendment to the Articles of Incorporation was recorded with the Florida Secretary of State on May 5, 1997 and filed in the Official Records of St. Lucie County Florida at Official Records Book 1075, Page 0263, et.seq. The same Articles of Incorporation are hereby amended as approved by the membership by vote sufficient for approval at a Members' Meeting held on June 15,1999.

1. Article IX is amended as follows:

ARTICLE IX - BY-LAWS The Bylaws of the Corporation may be made, amended, altered or rescinded at a regular or special meeting of the members, by a vote of fifty-five percent (55%) of those members present and voting in person or by proxy; provided that those provisions of the Bylaws which are governed by these Articles of Incorporation may not be amended except as provided in the Articles of Incorporation or applicable law.

2. Article X is amended as follows:

ARTICLE X - AMENDMENTS TO THE ARTICLES OF INCORPORATION These Articles may be amended altered or rescinded at a regular or special meeting of the members, by a vote of fifty-five percent (55%) of those members present and voting in person or by proxy; and provided further that no amendment shall be effective to impair or dilute any rights of members that are governed by the recorded covenants and restrictions applicable to The Properties (as, for example, membership and voting rights) which are part of the property interests created thereby.

- 2. The foregoing amendments to the Articles of Incorporation were adopted as approved by the membership by vote sufficient for approval at a Members' Meeting held on June 15, 1999.
- 3. The adoption of these amendments appear upon the minutes of said meeting and is unrevoked.
- 4. All provisions of the Articles of Incorporation are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
