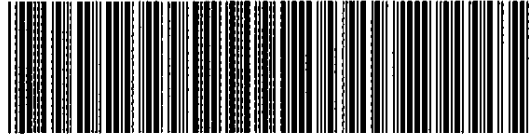

Amendment No. 1: Article 10, Articles of Incorporation

10. **Amendment to Articles.** These Articles of Incorporation may be amended, altered or rescinded only with the approval of ~~not less than two-thirds of the Board of Directors and not less than 75% of the members of the Corporation~~ a majority of the Voting Interests of the Association present (in person or by proxy) and voting at a duly noticed meeting at which a quorum is present.

Amendment No. 2: Article 9, Articles of Incorporation

9. **Bylaws.** ~~The original Bylaws shall be made by the Board of Directors and/or declared under the Declaration of Condominium. The same may thereafter be amended, altered or rescinded only with the approval of not less than a majority of the Board of Directors and not less than 75% of the members of the Corporation.~~ The Bylaws of the Corporation may be altered, amended, or repealed in the manner provided in the Bylaws.
