

ARTICLES OF INCORPORATION OF EAST LAKE WOODLANDS CYPRESS ESTATES CONDOMINIUM UNIT TWO ASSOCIATION, INC.

- 1. Article 5, Directors, Section 5.1, Number and Qualifications, of the Articles of Incorporation shall be amended to read as follows:
