ADOPTED AMENDMENTS TO THE ARTICLES OF INCORPORATION OF TERRACE PARK OF FIVE TOWNS, NO. 24, INC.

1. Adopted amendment to ARTICLE VIII of the Articles of Incorporation of Terrace Park of Five Towns, No. 24, Inc. (the "Articles"), to read as follows:

VIII.

The By-Laws of the corporation are to be made, altered or rescinded as provided in the By-Laws by a three-fourths (3/4) vote of the members of this corporation, save and except as provided for in the Declaration of Condominium of Terrace Park of Five Towns No. 24, a condominium, recorded among the Public Records of Pinellas County, Florida, as it pertains to correcting errors and/or omissions in the Declaration of Condominium or in any other documentation required by law to establish the condominium form of ewnership.

2. Adopted amendment to ARTICLE XI of the Articles, to read as follows:

XI.

These Articles of Incorporation may not be amended, altered, modified, changed or rescinded by a vote of less than three-fourths (3/4) two-thirds (2/3) of the then present members of the corporation, which may be accomplished at any regular or special meeting of the corporation, provided that written notice of the proposed change shall have been mailed to each member of the corporation fourteen (14) days prior to said meeting of the corporation, provided, however, that no such alteration, amendment, modification, change or rescission of Article II hereinabove, and of Sections 6, 7, 8, and 10 of Article X, may be made without the unanimous approval of the then members of the corporation together with the written unanimous approval of all mortgagees holding a valid, enforceable first mortgage lien against any condominium unit
