CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF OAK COURT OF OAK TERRACE CONDOMINIUM ASSOCIATION, INC.

As used herein the following shall apply:

- A. Words in the text which are lined through with hyphens (----) indicate deletions from the present text.
 - B. Words in the text which are <u>underlined</u> indicate additions to the present text.
- 1. Article III, Section 6 of the Articles of Incorporation is hereby amended as follows:
 - "6. To make and amend reasonable regulations regarding the use of the property of the condominium; provided, however, that all such regulations and their amendments shall be approved by not less than seventy five percent (75) of the votes of the entire membership of the Association before such shall become effective."
- 2. A new Article III, Section 12 is added to the Articles of Incorporation, which provides as follows:
 - "12. To enter into agreements with the Oak Terrace Property Owner's Association, Inc. ("Association"). Said power shall be limited to those agreements which are for the benefit and enjoyment of all members of the Property Owner's Association."

The number of votes cast by the members entitled to vote was sufficient for approval of these amendments and same were adopted March 24, 1988.
