

'AMENDMENT TO ARTICLES OF INCORPORATION OF

PRESBYTERIAN HOMES AND HOUSING FOUNDATION OF FLORIDA, INC.



WHEREAS, Presbytery of Tampa Bay, Inc. and Peace River Presbytery, Inc. have formed and established Presbyterian Homes and Housing Foundation of Florida, Inc.;

WHEREAS, the Board of Directors have recommended amendments to the Articles of Incorporation of Presbyterian Homes and Housing Foundation of Florida, Inc., and the members of the corporation have approved those recommendations;

NOW THEREFORE, the Articles of Incorporation are hereby amended as follows:

A. <u>Article II. Purpose</u>: Is deleted in its entirety and the following substituted therefore:

Article II. Purpose

The purpose for which the Corporation exists are as follows:

- 1. To develop and administer programs for development and redevelopment of Presbyterian housing and related facilities.
- 2. To develop, promote, maintain and improve affordable housing and related facilities to help satisfy the housing needs of aged, handicapped and low to moderate income persons at the lowest feasible cost.
- 3. To develop and provide central management for affordable housing and related facilities in a manner designed to satisfy the primary housing needs of aged, handicapped and low to moderate income persons at the lowest feasible cost.
- 4. To develop and provide programs for the social and spiritual well-being of the residents of the Presbyterian housing and related facilities.
- 5. To develop and administer programs for special giving for the support of Presbyterian housing and related facilities including the powers to accept, hold, invest, reinvest, and administer any gifts, bequest, devises, benefits or trusts, and property of any sort, without limitation as to amount or value and to use, disburse, or donate the income or principal thereof for education, charitable, and other religious purposes of the Presbyterian housing and related facilities.

- 6. To operate exclusively for such religious, educational and charitable purposes specified above as will qualify it as an exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1954 or corresponding provision of any future United States Internal Revenue Law.
- 7. To exercise all the powers conferred by the laws of the State of Florida upon corporations not for profit, to the extent that such powers are neither in conflict with the purposes of the corporation nor with the directions of the PRESBYTERIES.
- 8. Notwithstanding any other provision of these Articles, this corporation will not carry on any other activities not permitted to be carried by (a) a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 (and/or the corresponding provision of any future United States Internal Revenue Law) or (b) a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1954 (and/or the corresponding provision of any future United States Internal Revenue Law).
- 9. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statement) any political campaign on behalf of any candidate for public office.
- No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to, its Members, Directors, Officers or other persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for the services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.
- B. <u>Article V. Office and Agent:</u> Is deleted in its entirety and the following substituted therefore:

Article V. Office and Agent

The registered agent of the Corporation in the State of Florida will be at 1050 Burlington Avenue North, St. Petersburg, Florida 33705. The registered agent of the Corporation in the State of Florida at the registered office is Deje Kondor.

C. <u>Article VIII. Members:</u> Is deleted in its entirety and the following substituted therefore:

Article VIII. Members

The Corporation shall have members, the private property of whom shall not be liable for the debts of the Corporation. With the exception of no more than 6 at-large members to be elected by the Corporation, the members of the Corporation shall be elected by the PRESBYTERIES, which shall determine the requirements for qualification, admission, termination and all other terms and conditions of membership. The membership shall consist of no fewer than 18 members requiring at all times that the members elected by the PRESBYTERIES shall hold a minimum of 2/3 majority which shall also be the requirement to establish a quorum at all meetings of the membership. It is the intent of these Articles that the members be accountable and responsible to the PRESBYTERIES, (or their successor or successors) as a unit(s) of the Presbyterian Church (U.S.A.).

D. Except as modified by this Certificate of Amendment, the Articles of Incorporation of Presbyterian Homes and Housing Foundation of Florida, Inc. and all other terms and conditions shall remain the same and in full force and effect.

IN WITNESS WHEREOF, the undersigned officers do hereby certify that the foregoing Certificate of Amendment to the Articles of Incorporation was adopted and accepted by a majority of the Board of Directors and members on the 16th day of March, 2006.
