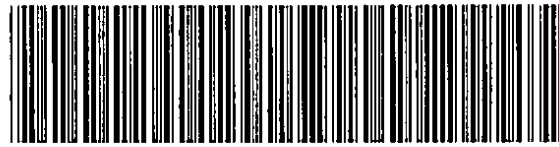

The following is an amendment to the Articles of Incorporation of Highland Lakes Villas on the Green Condominium III Association, Inc., originally recorded at Official Records Book 5055, Page 1700, et. seq. of the Public Records of Pinellas County, Florida, as amended.

New Wording Underlined; Deleted Wording ~~Stricken Through~~ (Except when proposed amendment involves substantial rewording):

Article III, Section 3.2, subsection f is amended to read as follows:

3.2 The Association shall have all of the powers and duties set forth in the Condominium Act except as limited by these Articles and the Declaration of Condominium, and all of the powers and duties reasonably necessary to operate the condominium pursuant to the Declaration as it may be amended from time to time, including but not limited to the following:

...
f. To make and amend reasonable regulations respecting the use of the property in the condominium; provided, however, that all such regulations and their amendments shall be approved by not less than 75% a majority of the votes of the entire membership of the Association before such shall become effective.
