

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF LAKEWOOD ASSOCIATION, INC.

Pursuant to the provisions of §617.1006, *Fla. Stat.*, LAKEWOOD ASSOCIATION, INC. ("Association") adopts the following Articles of Amendment to its Articles of Incorporation.

## FIRST: Amendment adopted:

Article X of the ARTICLES OF INCORPORATION OF LAKEWOOD ASSOCIATION, INC. ("Articles of Incorporation") is/are hereby amended as follows (additions are indicated by <u>underlining</u>; deletions are indicated by <u>strike-outs</u>, omitted and unaltered provisions are indicated by ellipses (...)):

These Articles of Incorporation shall only be amended by a vote of 60% (17/28) two thirds of the Unit owners. Voting may take place at any members' meeting or may be evidenced by the signature of the owner on amendments which may be proposed by either members or the Board of Directors. Amendments to the Articles of Incorporation shall not become effective until recorded in the Public Records of Lake County and filed with the Department of State of the State of Florida.

SECOND: The date of adoption of the Amendment was the 30th day of March,

2016.

THIRD: Adoption of Amendment:

Article X of the Articles of Incorporation, in effect prior to the adoption of the instant Amendment, provides that amendments to the Articles of Incorporation may be approved by the affirmative vote of two-thirds of the unit owners.

The members of the corporation were entitled to vote on the Amendment. The members of the Association duly adopted this Amendment in accordance with the above-stated provision. The number of votes cast for the Amendment was sufficient for approval.
