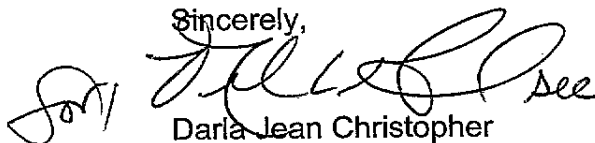

**ARTICLE ONE**

The name of this corporation shall henceforth be : INDUSTRIAL  
COMPLEX OF RAIFORD, INC.

**ARTICLE TWO**

The term of existence of the Corporation is perpetual.

The Corporation is organized in order to engage in any lawful purpose or  
purposes not for pecuniary profit and charitable as defended in Section 501

#### **ARTICLE EIGHT**

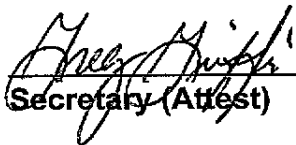

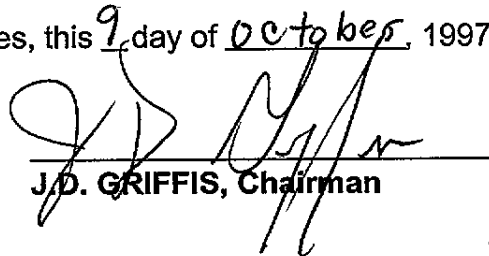
#### **ARTICLE NINE**
